Elisabeth,

Thank you for all your continued support. I do have a question regarding a very difficult physician who is requesting to speak with someone from Lilly regarding zyprexa and diabetes. I had scheduled Dr. Breier to meet with this practitioner, but due to Dr. Breier's recent job change, we had to cancel that appointment.

Dr Arbuck is a psychiatrist who has an out patient practice but he is also a big player at one of our largest hospitals systems which includes a CMHC as well, Community Hospitals, Gallahue Mental Health and inpatient services for Adult and Child Mental Health Services. He FIRMLY believes, and has a theory, that zyprexa effects gaba and the pancreas in such a manner that metabolically, zyprexa causes diabetes. He says he has seen it in his practice. We have given the company verbatims and brand messages, we have sent medical letters, had speakers into his office and even T. Corya from the zyprexa brand went out with us to "hear" his experience and his theory.

This physician is an influencer and he is on a mission to let everyone know how zyprexa does directly cause diabetes. He has requested that someone from Lilly to come see him, and to "write up his theory", since he has been doing "a study." My concern is how he is impacting the business here locally.

Our market share has dropped in the zip codes where he is an influencer, which is several areas. Since the closure of several local psychiatric outpatient offices of st. vincent and st francis, along with the inpatient psychiatric bed reduction at st vincent and the inpatient closures at st. francis, many of the patients are going to Community Hospital, the Gallahue Systems and Adult and Child, where Dr. Arbuck practices and is picking up more patients. Everywhere I go, I hear about how Dr. Arbuck is starting patients on anything but zyprexa in the hospital or taking them off zyprexa, starting them on something else and then discharging them to stay on the other meds. I hear so many practitioners telling me that along with the media, Dr. Arbuck's theory concerns them. One of his friends who is national speaker for us, is now starting to wonder if maybe his theory is true.

Anyway, I am not sure who would be best to go see him but we could really use help with this one MD. Maybe I should do a formal request to Karen but wanted to get your input on what you would do at this point in terms of resources and also in light of his agenda....which is to be heard, as he is fully convinced of his theory and feels that Lilly must listen to him.

Thank you for your advice and any assistance in the matter. The other issues are minor and under control in comparison to this ongoing challenge with Dr. Arbuck. I have dealt with this for about a year and hoped to change his mind or that his experiences would prove different but......this has not been the case.

I am very grateful for all your voicemails, emails and ongoing assistance as I realize you are already very busy.
